CALL TO ORDER AND WELCOME

Mayor Trapnell called the meeting to order and welcomed everyone.

PLEDGE OF ALLEGIANCE

Councilman Thomas led the Pledge of Allegiance.

INVOCATION

Councilwoman Colson gave the invocation.

PURPOSE

The purpose of this meeting was to consider passing three resolutions as follows:

1. Resolution calling for a referendum question by the electors for the purpose of approving or rejecting Sunday Alcohol Sales for on-premises consumption.
2. Resolution calling for a referendum question by the electors for purpose of approving or rejecting Sunday Alcohol Package Sales.
3. Resolution adopting the Joint Comprehensive Multi-Hazard Mitigation Plan as the official Plan of the City of Metter.

Resolution- Referendum Question – Sunday Alcohol Sales On-Premises

Councilwoman Kilcrease made a motion to approve a resolution by the Mayor and Council of the Metter, Georgia calling for a referendum question by the electors for the purpose of approving or rejecting Sunday Alcohol Sales for on premise consumption. Councilwoman Colson seconded the motion, and the vote was three in favor and two opposed. Councilman MacGregor and Councilman Thomas cast the opposing votes. The motion passed.

Resolution – Referendum Question – Sunday Alcohol Package Sales

Councilwoman Kilcrease made a motion to approve a resolution by the Mayor and Council of Metter, Georgia calling for a referendum question by the electors for purpose of approving or rejecting Sunday Alcohol Package Sales. Councilman Boyd seconded the motion, and the vote was three in favor and two opposed. Councilman MacGregor and Councilman Thomas cast the opposing votes. The motion passed.

Resolution Adopting the Joint Comprehensive Multi-Hazard Mitigation Plan

Councilwoman Colson made a motion to approve a resolution adopting the Joint Comprehensive Multi-Hazard Mitigation Plan as the official Plan of the City of Metter. Councilwoman Kilcrease seconded the motion, and the vote was unanimous.

EXECUTIVE SESSION

Councilwoman Kilcrease made a motion to go into executive session to discuss personnel. Councilman Thomas seconded the motion, and the vote was unanimous.

After the discussion was complete, Councilwoman Colson made a motion to go back into open session. Councilwoman Kilcrease seconded the motion, and the vote was unanimous.

City Manager Contract Approval

Councilman MacGregor made a motion to approve a one year contract for Joseph M. Mosley as City Manager. Councilman Thomas seconded the motion, and the vote was four in favor and one opposed. Councilwoman Colson cast the opposing vote. The motion passed.

ADJOURNMENT

After no further discussion, Councilwoman Kilcrease made a motion to adjourn the meeting. Councilman MacGregor seconded the motion, and the vote was unanimous.
