**CALL TO ORDER AND WELCOME**

Mayor Trapnell called the meeting to order and welcomed everyone.

**PLEDGE OF ALLEGIANCE**

Councilman Boyd led the Pledge of Allegiance.

**INVOCATION**

Councilwoman Colson gave the invocation.

**APPROVAL OF AGENDA**

Councilwoman Kilcrease made a motion to approve the agenda deleting Item (b) Motion to approve Whitfield Sign's Municipal Gateway Signage Proposal. Councilman MacGregor seconded the motion, and the vote was unanimous.

**PURPOSE**

The purpose of the meeting is to consider a motion to approve a Continuing Resolution concerning the budget, authorizing City Staff to apply for West Vertia Street to become part of the City's TIA Local Project Delivery, and to approve the Mowing and Maintenance Agreement.

**Continuing Budget Resolution**

Councilman Boyd made a motion to approve a Continuing Resolution that will allow the City to operate at FY 2015 funding levels until a new FY 2016 budget is adopted. Councilman MacGregor seconded the motion, and the vote was unanimous.

**West Vertia Street to Become Part of the City's TIA Local Project Delivery**

Councilwoman Kilcrease made a motion to authorize City Staff to apply for one municipal street (West Vertia Street) to become part of the City's TIA Local Project Delivery. Councilman Boyd seconded the motion, and the vote was unanimous.

**Mowing and Maintenance Agreement for the Transportation Enhancement Project**

Councilwoman Colson made a motion to approve the Mowing and Maintenance Agreement for the Transportation Enhancement Project for the downtown streetscape. Councilman MacGregor seconded the motion, and the vote was unanimous.

**EXECUTIVE SESSION**

Councilwoman Kilcrease made a motion to go into executive session to discuss real estate. Councilman MacGregor seconded the motion, and the vote was unanimous. Mayor Trapnell exited the meeting due to a conflict of interest.

After the discussion was complete, Councilman MacGregor made a motion to go back into open session. Councilwoman Colson seconded the motion, and the vote was unanimous.

**ADJOURNMENT**

After no further discussion, Councilwoman Kilcrease made a motion to adjourn the meeting. Councilman MacGregor seconded the motion, and the vote was unanimous.
