

**CITY OF METTER, GEORGIA**  
**REQUEST FOR QUALIFICATIONS AND PROPOSALS**  
**Planning, design, administrative, cost and related services**

The City of Metter, Georgia is requesting statements of qualifications, proposals and cost from engineering consultants with a strong record or qualifications, which will enable it to successfully assist the local government with development and implementation of resurfacing 3 city streets using Transportation Investment Act (TIA) funds. The 3 city streets are as follows: (1. Burton Avenue from Franklin Drive to E. Turner Street and from E. Turner St. to Guido's Driveway; (2. S. Kennedy St. from S.W. Broad Street (Hwy 46 W.) to W. Hiawatha Street; (3. S. Williams Street from S.W. Broad St. (Hwy 46 W.) to W. Vertia Street and S. Williams Street from W. Pine Street to W. Hiawatha Street. There will also be a water main upgrade on Burton Avenue of a 2" galvanized line to a 6" PVC line. Responding firms should be qualified to provide planning, design, inspection and administrative services for these projects.

The City of Metter seeks to immediately contract for the planning, design, inspection and administrative related services for this project. All contracts are subject to Federal and State contract provisions.

Criteria for evaluation includes (1) knowledge of TIA guidelines and regulations, (2) experience in design and/or administration of this type project, (3) knowledge of the community, (4) workload and ability to meet the project schedule, and (5) track record for successfully administering previous TIA and water main upgrade projects. Proposers shall also cite examples of similar work in other communities, and include references from within those communities. References will be contacted and price will be considered after qualifications reviewed.

Consultants will submit proposals for services to include planning, design, administrative, inspection and related services. All proposals submitted should include the Consultant's Qualifications sheets.

Rountree St. to review the project.**
